The Youth Ranger Internship Program provides education and career preparation to youth in rural Hawaii. Youth train with park rangers in six different divisions within the park, including Interpretation, Natural Resources, Cultural Resources, Maintenance, Protection and Administration. Youth rangers served 52 youth over 8 weeks.
